Rules Governing the Use of the Golf and Sports Center

1. Application must be made and contract signed by an authorized Buffalo Grove Park District representative and is valid only on the dates and times shown. Due to multi-recreational use of the facility by various groups, your listed start time indicates time for entry into the facility. Any players, parents, coaches, trainers or team/rental representative arriving earlier than listed start time will result in partial or full forfeit of deposit.
2. Notification is required 45 days in advance for cancellation of a rental date if a refund is to be issued. When multiple rental dates have been booked, a credit will be applied to the account toward future dates. If additional dates are not booked, a refund will be issued at the end of the rental contract provided the 45 day notification was done.
3. Contracts shall be canceled, should the Park District determine that usage will damage the facility.
4. Contracts may be canceled and future permits denied and deposits lost if:
 - The individuals are in violation of any ordinances, rules or regulations of the Buffalo Grove Park District.
 - Participants engage in disorderly conduct, littering or damaging Park District property.
 - The Golf and Sports Center office is not notified 45 days prior to rental date if a cancellation is necessary.
5. Food or drink cannot be brought into the facility during sport practice rentals. Our concession area has these items available for sale.
6. Food vendors are allowed during private party rentals with approval. No food or drink is allowed on the turf and must remain on the concrete portion of the facility.
7. Cleats are not permitted inside the facility.
8. As per Buffalo Grove Park district Ordinance 93-3-2 Section 21, a special use permit must be issued in order to operate any sound amplification device on Park District property.
9. The posting of advertisements for any products or services is not permitted.
10. Playing field, lobby and other facility areas shall be left clean of debris after usage.
11. Alcohol and smoking are not permitted on Buffalo Grove Park District property.
12. Profit making group requests may be denied for one of following reasons:
 - Program conflicts in nature with a program being offered by the Buffalo Grove Park District.
 - Group fails to supply the Buffalo Grove Park District with a certificate of insurance naming the Buffalo Grove Park District as additional insured.
 - The group fails to comply with any of the other listed rules and regulations.

It is fully understood and agreed to by all parties that the sponsoring organization guarantees to indemnify and hold harmless the Buffalo Grove Park District, its public officials, employees, volunteers and agents against any and all suits of any manner which might arise as a result of the covered activities and that the sponsoring organization agrees to defend said Park District, its public officials, employees, volunteers and agents and indemnify same against any and all expenses incurred in the defense of any suit of any type arising out of the covered activity or any damages, judgements or decree which might be awarded against said District in the event that the suit should be brought as the result of the covered activity(ies) as identified above. I understand I will be charged for any damages to the building, and time spent for clean up by our staff if required. The Park District reserves the right to make adjustments in these fees as necessary. Damages over and above the deposit fee will be charged to the group and/or contact person named on this application. Photo Disclaimer: Participants permit the Park District to take photos and videos of themselves and their children for publication in the program brochure, web site and additional uses as the Park District deems necessary unless the registrant or participant expressly files with the Park District a written objection as to photos or videos of themselves and/or their children.
